## Payment Plans 2010/2011

**PLAN 1:**

Payment due in full by December 1 (\$2360)

**PLAN 2:**

3 Payments due December 1, 2010 (\$787.00),  
January 15, 2011 (\$787.00) and February 28,  
2011 (\$787.00)

### TERMS OF AGREEMENT:

If at any time after signing this agreement a child leaves the Morning Rose,  
the family is under the following obligations:

(1) Prior to January 5th (first day of program), 10% of the total (\$236.00).

(2) After program start date and before January 5th, 20% of the total  
(\$472.00)

(3) After January 30th, 100% of the total tuition (\$2360.00)

If the faculty determine within 30 days of a program start date that a  
student is not appropriately placed in a program, tuition for the program  
will be pro-rated on a per month basis regardless of what day in the month  
the student withdraws, and a credit or a refund will be issued accordingly.

If a payment is 60 days or more overdue the student(s) will not be allowed  
to attend school until payments have been brought fully current or terms  
satisfactory to the school have been agreed upon.

There is no financial aid for this program.

Parents can enroll in the Tuition Refund Plan. This plan gives families the  
opportunity to insure tuition (prepaid and due) in the event of separation  
from the Hartsbrook School according to the terms of the policy. Please
